- EDGE CONDITION LEGEND**
- E1 - 8" (H) TO 3'-6" (H)(VARIES) X 1'-6" (W) PARAPET WALL. REMOVE EXISTING METAL COPING AND ALL WALL FLASHINGS. INSTALL FULLY ADHERED WALL FLASHING UP OVER EXIST. TOP PLATE AND DOWN FRONT FACE, INSTALL NEW TWO PIECE METAL FASCIA (SEE DET. 0001)
 - E2 - 7'-0" (H) TO 9'-0" (H)(VARIES) X 1'-6" TO 2'-0" (W) SLOPED WALL. REMOVE EXISTING METAL COPING AND ALL WALL FLASHINGS. INSTALL FULLY ADHERED WALL FLASHING UP OVER EXIST. TOP PLATE AND DOWN FRONT FACE, INSTALL NEW TWO PIECE METAL FASCIA (SEE DET. 0001)
 - E3 - RAISED GRAVEL STOP EDGE METAL, REMOVE EXISTING EDGE METAL, INSTALL NEW GRAVEL STOP EDGE METAL W/ FULLY ADHERED FLASHING (SEE DET. 0002) (SEE PLAN DRAWING FOR SCUPPER OPENINGS IN EDGE METAL)
 - E4 - 1'-0" (H) WALL FLASHING, REMOVE ALL FLASHINGS FULLY ADHERE NEW WALL FLASHING, INSTALL TERM BAR, SEALANT AND NEW SURFACE MOUNTED COUNTER FLASHING W/ SEALANT JOINT (SEE DET. 0003)
